#### Security System Presentation Peter Rebuzzini

- Chris Barrow presented on indoor security. His background is law enforcement and security, and emergency management, his experience in is with schools and churches.
- A flipchart will be placed in each room in the church and church school building, and next to every exit. Chart covers various emergencies, including health. Lists step-by-step what to do during an emergency.
- If there are concerns about safety, call 911 first.
- Terrific overview and have some next steps for church safety and security. Chart will help us stay calm in an emergency.

## Discussion and possible action on Boy Scouts Bankruptcy and Annual Charter Agreement

### **Charter Agreement**

- Concerns about the future of the Boy Scouts and our involvement as sponsors. Two issues:
   1. Bankruptcy 2. How does the troop go forward? Church is party to the bankruptcy as a sponsor. Three options for us:
  - If we do nothing we would not be covered or protected from any law suit claims to the Boy Scout Organization.
  - If church makes substantial contribution to the settlement fund, we would be covered. There is no definition of "substantial."
  - Church can choose to elect coverage that is limited by the size of the settlement fund (least horrible option).
- If someone makes a claim against a troop, we could be liable as a sponsor. The Boy Scouts of America filed for bankruptcy because it was overwhelmed by claims.
  - Stephen provided us with a draft of an annual agreement that we would have to sign as the "Chartered Organization" or sponsor of the Troop. The Troop has always had something like this. The agreement needs to be signed by the end of the year so that our troop can continue to exist after the New Year. Are we interested in continuing to sponsor the Troop? Are we willing to abide by all of the items in the Charter Agreement? By signing this agreement are we obligating the church to more than we have done in the past?

- Ginger expressed concern over the "oversight" listed in the agreement.
- Bill Speed expressed concern over our liability for organizations who use the church's space-Neighborhood Music School as a comparison, but they rent space. The troop doesn't rent space. The troop needs a sponsoring organization to survive.
- Keeping the Troop in compliance with the agreement is a big job- Anne Godsey did it in the past. Do we have the people to do it? We are having trouble filling Church committee positions. What is the legal liability if we don't hold up our obligations per the agreement?
- Peter R. moved that we continue to support the Troop for a year and see how it goes. Bob Howard seconded. Ginger amended that if the motion passes, then we must have the appropriate people to monitor and oversee. (Two church members willing to take this on.) Susan seconded the amendment. Motion passed. Lou Federici said he is committed to making sure there are appropriate people in place to oversee the Troop.

## Discussion of request to light Christmas tree in Sanctuary Stephen Dudley

 Deacons make decisions about Sanctuary, but Stephen presenting idea to Council first regarding electric lights on tree. Do lights detract from the worship service? Several members agreed that lights would detract from worship. Stephen will refer issue to Deacons.

#### **Board of Finance**

 New Standard Operating Procedures being edited. Hope to present at Annual Meeting.

#### **Budget for 2022**

 Continue to move forward. Stewardship pledges average 10% greater than previous pledges. Only at 85% of target. Stephen reminded us that Stewardship is an "everybody" issue, not just the committee.

#### Minister's Report

 The 25<sup>th</sup> Anniversary of First Church becoming an Open and Affirming Congregation is in February. We will reaffirm the covenant at the Annual Meeting. Deacons are tweaking some of the language to bring it up to date. Stephen will put adoption of the new language on the January Council agenda.


## GROCERY CARDS AVAILABLE TO PURCHASE After Worship in the Narthex

#### **ECO Echo**

Happy New Year!! The Environmental Ministry Team's theme for this year is "Waste Not." Topics to be explored will include reducing food waste and composting to minimize environmental impact, and Ocean Plastics impact on Marine life.

This article focuses on how our plastic waste is impacting God's marine creatures. Future articles will discuss what we can do to reduce the plastic waste that is making its way into our oceans. The information used for this article is the paper published by Oceana, November 2020: Choked, Strangled, Drowned: The Plastic Crisis Unfolding in Our Oceans – Oceana, USA: <a href="https://usa.oceana.org/reports/choked-strangled-drowned-plastics-crisis-unfolding-our-oceans/">https://usa.oceana.org/reports/choked-strangled-drowned-plastics-crisis-unfolding-our-oceans/</a>. It is written for the non-scientist and I encourage you to

download it.

In 2019, news outlets across the world reported on a beached whale that died after ingesting more than 88 pounds of plastic. It had starved, and its digestive acid, unable to break down the



compacted mass filling its stomach, had begun eating away at the animal from the inside out. But not all incidents like this make the news.

Oceana has compiled for the first time the available data on plastic ingestion and entanglements in marine mammals and sea turtles in U.S. waters. This begins to paint a picture of an unfolding disaster: the flood of plastics into our oceans and the devastating impact it is having on marine life.

The biggest problem found was animals consuming plastic. Animals mistake plastic for food or inadvertently swallow plastic while feeding or swimming. The result is that it obstructs their digestion or lacerates their intestines, interfering with the ability to obtain the nourishment needed, leading to starvation and death. When animals become entangled in plastic, they can drown, choke to death or suffer physical trauma, such as amputation and infection. Entanglement can also lead to malnutrition when it prevents their ability to feed properly.

Some the report's key findings:

 Eighty-eight percent of the nearly 1,800 animals identified in this report were species listed as endangered or threatened with extinction under the Endangered Species Act.

- Plastics affected animals at all life stages, from recently hatched sea turtles to seal mothers with actively nursing pups.
- In the cases where plastic ingestion was the likely cause of or contributor to death, seven involved just one piece of plastic.
- Plastics ranged in size and type, from microplastics that were perforating the gastrointestinal tract of a baby sea turtle to DVD cases and huge plastic sheets that had been swallowed by whales.
- Bags, balloons, recreational fishing line, sheeting and food wrappers were the most common types of identifiable plastics consumed by these animals. Plastic packing straps, bags and balloons with strings were the most common items entangling the animals.

#### **RE-ENTRY WELCOME CENTER VISIT**

First Church has had a long relationship with Community Partners in Action in Hartford. Charlotte White brought together Letty Russell, Shannon Clarkson and Deb Rogala of CPIA to establish a mentoring program with women re-entering society from prison. Rev. Sandra Wiens has kept this relationship alive since 2005. Pre-COVID, members of the Peace Affirmation and Justice Committee would visit MARTS House at Christmastime to bring cheer and gifts to the women living there, who were easing their way back to the community after prison terms. This year COVID kept us from visiting the On December 15, Sandra, Gay Harter, Shannon Clarkson and Judi Wallace visited the Reentry Welcome Center instead and were warmly welcomed by staff members Virginia Wallace and Amy Arroyo, who received our gifts for the women. Individuals returning home from incarceration can find welcome and support at the Welcome Center information. serviceshousing. substance abuse/mental health referrals, employment advice, identification help and much more.

The Center has been successful in connecting formerly incarcerated individuals with resources and preventing recidivism. It was awarded a federal grant as well as has continued support from the Hartford Foundation and the City. They have plans to expand space and support services. We left with a much greater appreciation of the crucial nature of the Center's work and delight that we continue in partnership in this ministry.
